While promoting international business development, entrepreneurship, and investment engagements to benefit enterprises, the Department of Health - Abu Dhabi (DoH), the regulator of the healthcare sector in the emirate of Abu Dhabi, today launched SAHATNA, an integrated-mobile app. The app empowers residents to manage their health by providing simple and convenient access to a wide range of health and wellness services such as comprehensive appointment booking, teleconsultations, access to health records and genomic reports and many other advanced features. The application is set to spur on emirate-wide behaviour change that will lead to improved long-term health outcomes and a healthier future for all.

The unveiling of SHATNA app was attended by Mansoor Ibrahim Al Mansoori, Chairman of DoH, Dr. Noura Khamis Al Ghaithi, Under-Secretary of DoH, along with several prominent leaders and representatives of partners and stakeholders. SAHATNA, meaning "Our health" in Arabic, marks a significant milestone in the Department of Health's ongoing commitment to harnessing the power of data to create the world's most intelligent, patient-centric healthcare system. Continually, addressing the unique health needs of Abu Dhabi's community and ensuring a healthier future for all residents.

SHATANA app, includes innovative features like an AI symptom checker, allowing users to input their symptoms and receive potential condition assessments. This tool helps users understand the severity of their symptoms and decide whether to seek emergency care or visit an urgent healthcare Among the key features, with SHATANA app,'s robust appointments scheduling system, users will have access to the emirate's entire healthcare ecosystem at their fingertips and choose to engage with their care providers in-person or through a video consultation. Users can also access their medical records in Malaffi and connect the profiles of their loved ones,

keeping track of their family's health as well as screening and vaccine records. Through SAHATNA, for the first time, the participants of the Emirati Genome Program (EGP) will have access to their personalised wellness and lifestyle genomic reports, empowering them to make informed decisions about their health and lifestyle based on their unique genetic makeup.

This includes enhancements to accessing primary healthcare and IFHAS screening services as well as an AI patient assistant to help users effectively navigate the app and help with their health questions."

Dr Ibrahim AL Jallaf stressed on the Best Doctor Section, within SAHATNA app. as he goes explaining how it works “A doctor focuses search is rather than hospital search” he said. May be, for reaching out a family doctor who can see one’s in a very short notice appointment, to be obtained through the app. “I can meet the Doctor at 11pm or even by night. We are working on a doctor rating we do it In a very careful way, managing the patients and doctor “he said as he mentions the due respect towards the doctors and the patients, avoiding any bias is choosing one doctor over another, yet in a more specific approach of choosing a Physician that matches the specific needs, according to the current symptoms as they appear during the search over the app SAHATNA.

As we asked the question to Dr Ibrahim AL Jallaf whether the bias can be reduced to the minimum, when it comes to targeting a preference and also how to match the most the psychical symptoms and the medical response he answered “We use the Geodimetric educate the AI complication rates and it is also important to our population. We then use the AI symptoms checker for that purpose”

Our reporter asked Dr Ibrahim AL Jallaf how far the personal data are protected as we speak about the most intimate and most precious data any patient would like to be safe and protected from any stranger’s indiscreet access, nor exploiting them for mercantile purposes, he answered “SAHATANA app requires the consent management of personal data access management over 18 years old. Above that age, one can have access to their medical digital file, by just log in their version with SHATANA app. As far as the safety is concerned, we have implemented a double level of security.

Our reporter as she is aware of the GDPR European Union’ law, wondered whether SHATANA app, is complying with E.U GDP, U.S COPPA, as the United Arab Emirates are representing the largest hub in the world hosting residents and tourists from 190 nations.

The question was asked to Dr Ibrahim AL Jallaf, who replied “We use point to point network, through network to reduce the vulnerability we have three layers Malafi security and our cyber-protection hits the most advanced level, as they are monitoring and private network layers and layers private network for security purposes. We of course collect our national data in our sovereign cloud only within the UAE.
